## From the Rector

Dear Friends,

Another Synod sitting has passed! Perhaps for some that is a relief, they are long days sometimes listening to finer points of legislation that might seem trivial but to the legal mind are crucial. I for one am very grateful to those who can think in a forensic way, it doesn't come naturally to me. Fortunately this year's sitting passed without contention. Bishop Stuart has written to the Clergy expressing his gratitude. He wrote: 'A great many thanks for your attendance and participation in our Synod. Your willingness to prayerfully and respectfully work through legislation and reports and engage in edifying debate was an encouragement to all concerned.'

One interesting motion came forward which I feel required more debate and discussion. It concerned the 500th Anniversary of the event that kick started the Protestant Reformation; in October 1517 Martin Luther nailed his 95 Theses to the door of the Castle Church at Wittenburg. Luther was primarily railing against the sale of indulgences by a representative from Rome to raise money for the building of St Peter's. An indulgence is a document which can be purchased; the document assured the purchaser that he or she will have less time in purgatory

- a time or place after death when we are purged of our sins before entering the heavenly court. Luther suggested, among other things, that the Pope should spend his own money building his basilica not that of the poor and gullible.

The motion asked the Synod to note the occasion and to give thanks for the Reformation doctrine of salvation by grace alone, through faith alone, in Christ alone, revealed through scripture alone for God's glory. The Synod passed this motion but not without debate. At question was the notion of Sola Scriptura or Scripture alone; is this consistent with Anglican thought? Might the fact that we were meeting in synod suggest that the doctrine of 'Scripture Alone' was inconsistent with our Anglican way?

Richard Hooker arguably the preeminent Anglican theologian in the Elizabethan period wrote: 'Be it in matter of the one kind or of the other, what Scripture does plainly deliver, to that the first place both of credit and obedience is due; the next whereto is whatsoever any man can necessarily conclude by force of reason; after these the Church succeeds.' So rather than scripture alone we as Anglicans - I would argue - look to scripture first, from there we depend upon our God given reason and from there the living voice of the Church, expressed in tradition which is the church's ongoing life....including synod.

I am just grateful there were no arguments! We all got along famously!

## KEY POINTS FROM OCTOBER PARISH COUNCIL MEETING

- There will be a pre-Advent Working Bee on Saturday 18 November from 9-11am for the church and garden.

## 2017 Synod Representatives' Report to St Philip's

We attended the Diocese of Canberra and Goulburn Synod at the Goulburn Workers' Club on 6–8 October on behalf of St Philip's. Here are some items that may interest our fellow Philipians.

### Finance

Diocesan finances are in reasonable shape, but help and compensation for victims and other costs arising from the Royal Commission into Institutional Responses to Child Sexual Abuse totaled around \$900,000 in 2016 with perhaps \$2 million in future liabilities. We have had to dip into reserves to meet these payments although we are in better shape than some dioceses as to the scale of the need and its consequences. Meanwhile, the Anglican Investment and Development Fund (AIDF) —a kind of church bank—is in fine shape with \$110 million in assets.

### The Royal Commission

With remarkable unanimity, the September 2017 meeting of General Synod made important decisions in response to the work of the Royal Commission. There will be a special half-day meeting of our Synod in March 2018 to implement those decisions in our diocese.

### Education

All seven schools are developing well, although there has been a heavy interest bill from a \$32 million assistance package for the South Coast Schools. St Martin's, the Anglican residential college for 96 students of Charles Sturt University at Wagga Wagga, is debt-free and meeting an important need, both spiritually and residentially. All Saints College in Ainslie is similarly valuable.

## Reports and presentations

There were quite a number of finely-produced reports and presentations, including from the ACCC, Anglicare, the AIDF, Bishop-in-Council, St Mark's, the Public Issues Commission, the Schools Commission, and Synergy Youth. Please talk to Brian if you would like an electronic copy of any report.

## Resolutions

A resolution on the future of **off-shore processing** passed 193 to 26. A resolution calling for legislation against **modern slavery** passed unanimously. After considerable difficult debate, the Synod adjourned a motion on **assisted suicide / assisted dying** until next year. Other important resolutions were about Disability Inclusion, Relationships with First Nations Peoples and on Family Violence. The Synod also took note of the likely need to manage wisely our responses to same-sex marriage.

## Worship, prayer and fellowship.

Synod members shared enriching worship in the Cathedral, and in bible study and prayer. The deacons gathered for a dinner that Robin attended.
